Possible Continuing Professional Education Changes

he Texas State Board of Public Accountancy (TSBPA) is considering changes to its continuing professional education (CPE) *Rules*, which would allow licensees to receive CPE credit for sponsored nano learning and blended learning programs. "These new forms of learning are being introduced because national trends have recognized that people learn by a variety of methods. It remains to be seen how readily available these new programs will be and how well they will be received by CPAs," said TSBPA Executive Director William Treacy.

A nano learning program is defined as a tutorial program designed to permit a participant to learn a given subject in a 10-minute time frame through the use of electronic media and without interaction with a real-time instructor. Electronic media includes technology applications and processes and computer-based or web-based technology. Unlike a self-study program, a nano learning program is typically focused on a single learning objective and is not paper based. A nano learning program is not a group program, nor is it a substitute for comprehensive programs addressing complex issues.

A blended learning program combines multiple learning formats. Activities can include lectures, discussion, guided practice, games, case studies, and simulation. The varied delivery methods include group live, group Internet based, self study, or nano learning. The primary component of the program may be synchronous or asynchronous, allowing the participant to control a portion of the time and pace of the learning.

The proposed revisions to CPE standards would allow one-fifth (0.2) of CPE credit for nano learning and also one-fifth of other delivery methods after a minimum amount of credit has been awarded. Texas CPAs would continue recording their CPA credits through the Online Services options on the TSBPA website: www.tsbpa.texas.gov.

If the revisions are approved, they will be implemented in the late spring of 2017. The proposed revisions are a result of changes to CPE provider standards issued jointly by the National Association of State Boards of Accountancy (NASBA) and the American Institute of Certified Public Accountants (AICPA). "The addition of blended learning and nano learning meets the marketplace demand for greater flexibility and increased CPE options. These modernizations to the standards are in line with what we heard from our Future of Learning Task Force and reflect the current dynamic business environment CPAs operate in," said Clar Rosso, AICPA Vice President of Member Learning and Competency.

TSBPA Gave \$4.2 Million in Scholarships Over Five Years

he Board's fifth-year scholarship program provided 1,773 scholarships totaling \$4,275,624.62 in scholarships over the past five academic years (2012–2016). The scholarships aid disadvantaged students who need assistance financing a fifth year of college often necessary to meet the educational requirements to take the CPA Exam. Funds are allocated to participating Texas colleges and universities, whose financial aid offices make the decisions on providing scholarships to individual students.

The fifth-year scholarship program is funded by Texas certified public accountants (CPAs) who contribute a legislatively mandated \$10 fee to the scholarship program through their annual license renewal. The *Public Accountancy Act* (the *Act*) provides for the establishment and maintenance of the program. The Texas Legislature passed House Bill 2440 (81st Legislature Regular Session 2009) and Senate Bill 777 (82nd Legislature Regular Session 2011) transferring administration of the accounting scholarship trust fund for fifth-year accounting students to the TSBPA. No administrative costs were assessed by the Board to administer the scholarship program. The funds were established to provide financial assistance to students intending to take the CPA Exam.

Respondent firm issued audit reports on at least two public companies located within Texas while the firm license was expired: Biofuels Power Corporation of Humble and Woodgate Energy Corporation of Houston.

The certificate of each respondent listed below was not in compliance with the Board's continuing professional education (CPE) requirements as of the date of the Board meeting. Each respondent was suspended for the earlier of a period of three years, or until the respondent complies with the licensing requirements of the *Act*. Additionally, a \$100 penalty was imposed for each year the respondent continues to be in non-compliance with the Board's CPE requirements. The respondents were found to be in violation of *Section 523.111* (Required CPE Reporting) and 501.94 of the Board's *Rules*, as well as *Section 901.411* (CPE) of the *Act*.
