NEWS & UPDATES

Recent Rule Adoptions

Every four years, the Board's Rules Committee undergoes a rules review process to identify possible rule changes that may be needed. Rule amendments are also frequently initiated when the Board recognizes issues that have arisen as regulatory matters are addressed. Sometimes developments in the profession or industry, such as changes to the National Association of State Boards of Accountancy and the American Institute of Certified Public Accountants *Uniform Accountancy Act Model Rules* initiate rule revisions. Occasionally changes in required education, qualifications, or feedback received from licensees also facilitate the consideration of rule amendments.

Various Board committees identify and present proposed rule amendments to be presented at the next Rules Committee meeting, after also having been reviewed by the Governor's Office. The proposed amendments and any comments from the Governor's Office are presented to the Board's Rules Committee. Next, members of the Board's Rules Committee discuss and draft proposed rule amendments and present them to the Board for consideration. Board members discuss and vote on the proposed rule amendments during Board meetings. If a consensus is reached to approve the suggested revisions, then the Board-approved proposed rule amendments are sent to the [Texas Register](#) for publication to solicit public comment. The public has 30 days to review the proposed amendments and provide comments. If public comments are received, the Rules Committee may choose to incorporate further changes.

Once rules have been adopted by the Board, they are sent to the Office of the Secretary of State for publication in the [Texas Administrative Code](#), which includes the most up-to-date rules governing all aspects of certification and regulation for accounting professionals. Rule amendments are adopted under the [Public Accountancy Act](#) (the Act). *Texas Occupations Code*, §901.151 provides the agency with the authority to amend, adopt, and repeal rules deemed necessary or advisable to effectuate the Act.

The 20 rule amendments summarized below were adopted during the Board's past fiscal year (September 1, 2017 — August 31, 2018). To view all Board rules, please reference the [Texas Administrative Code](#).

Rule §501.83 Firm Names (Adopted March 2018)

The amendment to §501.83 clarifies that an LLC or similar business entity may use company in its firm name and makes it clear that a sole proprietorship may not use the term company unless the sole proprietorship has more than one CPA involved in the firm.

chairman from 1995 until 1997. Maresh spent more than 30 years with KPMG, during which time he served on the Board of Directors, as managing partner of the Houston office and southwest region of the U.S., and vice chairman of the firm.

Maresh held a Bachelor of Business Administration with honors in Accounting and a Master's of Professional Accounting with highest honors from The University of Texas at Austin. He was recognized as a Distinguished Alumnus of McCombs School of Business and was inducted into the University of Texas Business Hall of Fame.

Rule §501.83 Firm Names (Adopted July 2018)

The amendment to §501.83(a)(4)(B) deletes a reference to repealed §513.2 and replaces it with the correct reference: §901.355 of the Act, because the Board no longer registers foreign CPAs but issues a certificate based upon reciprocity.

Rule §501.90 Discreditable Acts (Adopted May 2018)

The amendment to §501.90 clarifies that if a state or federal court determines that a licensee has violated state or federal laws, or state and federal regulations, such as laws against sexual harassment or under the *Deceptive Trade Practices Act*, the Board could consider the violation to be a discreditable act and subject the licensee to disciplinary action by the Board.

Rule §501.93 Responses (Adopted May 2018)

The amendment to §501.93 will make it clear that licensees have a responsibility to provide information they have access to, which the Board believes is important to the investigation.

Rule §507.6 Employee Training and Education Assistance Program (Adopted September 2017)

The amendment to §507.6 no longer lists a specific dollar amount but clarifies that the fees will be established by the Board.

Rule §511.57 Qualified Accounting Courses (Adopted May 2018)

The amendment to §511.57 clarifies that the minimum of 30 semester hours of upper level accounting classes needed to qualify to take the UCPAE, that are repeated, may only be counted once to meet the requirement.

Rule §511.59 Definition of 150 Semester Hours (Adopted May 2018)

The amendment to §511.59 clarifies that the minimum of 150 semester hours of classes needed to qualify to take the CPA Exam, that are repeated, may only be counted once to meet the requirement.

Rule §511.92 Definitions (Adopted November 2017)

The amendment to §511.92 utilizes the best language for describing impairments.

Rule §511.94 Documentation of the Need for an Accommodation (Adopted November 2017)

The amendment to §511.94 also utilizes the best language for describing impairments.

Rule §511.122 Acceptable Work Experience (Adopted March 2018)

The amendment to §511.122 replaces federal government classification levels with job titles and clarifies work experience gained in client practice.

Rule §511.123 Reporting Work Experience (Adopted November 2017)

The amendment to §511.123 proposes language requiring the supervising CPA to affirm in writing that he/she has

supervised the work of the applicant for at least one year and expresses the opinion that the applicant is qualified to perform accounting work in accordance with professional standards.

Rule §511.124 Acceptable Supervision (Adopted March 2018)

The amendment to §511.124 assures that an applicant has evidenced sufficient work experience to become a CPA.

Rule §513.16 Death or Incapacitation of Firm Owner (Adopted March 2018)

The amendment to §513.16 replaces “sole proprietorship” with “sole CPA owner” to make it clear that the rule allows all single ownership firms to be permitted to operate for a limited time upon the single owner’s death or incapacitation to prevent irreparable damage to the firm.

Rule §515.8 Retired or Disability Status (Adopted November 2017)

The amendment to §515.8 provides guidance on what constitutes retirement, requires retired CPAs to identify themselves as “retired,” and expands upon what constitutes and what may be considered to be volunteer work performed in retired status.

Rule §519.7 Misdemeanors that Subject a Licensee or Certificate Holder to Discipline by the Board (Adopted November 2017)

The amendment to §519.7 puts in place the process for determining whether a misdemeanor conviction in another state is comparable to a misdemeanor in Texas, which would subject a licensee to possible disciplinary action.

Rule §520.3 Institutions (Adopted March 2018)

The amendment to §520.3 recognizes the Board’s fiscal year as beginning on September 1 of each year, removes the term reallocation because the referenced report does not relate to reallocation, and removes the seven day time requirement in subsection (d)(2)(A) because it is not used by the Board.

Rule §520.5 Award Amounts and Uses (Adopted March 2018)

The amendment to §520.5 establishes that the Board will determine the minimum and maximum award amount to a student under the scholarship program and eliminates the standard for over awards.

Rule §520.6 Allocations (Adopted March 2018)

The amendment to §520.6 does not make substantive changes but was made to help the reader better understand the allocation of awards.

Rule §525.1 Applications for the UCPAE, Issuance of the CPA Certificate, or Initial License (Adopted September 2017)

The amendment to §525.1 incorporates language from Chapter 53 of the *Occupations Code* regarding criminal convictions with additional revisions so that the rule

addresses only individuals applying to take the Uniform Certified Public Accountant Examination (UCPAE).

Rule §525.2 Applications for or Renewal of a License for Licensees with Criminal Backgrounds (Adopted September 2017)

The amendment to §525.2 incorporates language from *Chapter 53* of the *Occupations Code* regarding criminal convictions with additional revisions so that the rule addresses licensees applying for license renewal. The word “article” was added to subsection (c).

OTHER NEWS & UPDATES

Common Individual Licensing Questions from Texas CPAs

There are several common questions asked by Texas CPAs that the Board’s licensing staff answers every day by phone or by email. It is always a good habit to periodically check your license status through the Online Services menu at www.tsbpa.texas.gov to determine how much continuing professional education (CPE) you need to renew your license. You can also record CPE credits as you take courses throughout the year, rather than waiting until the last minute and risk being short due to unforeseen circumstances. Take a look at these common situations to make sure you are on the right track this year.

Recording CPE from nonregistered sponsors has improved:

Several weeks ago, the Information Resources Division of the Board updated the reporting tool Texas CPAs use to record CPE courses through [Online Services](#). The dropdown list for registered sponsors has been updated using a JavaScript filter for ease of use.

We are also now accepting online input of courses taken from nonregistered sponsors through the same reporting menu. There is no longer a need to submit a separate form to record these courses with the Board. Simply select the radio button for a nonregistered sponsor and complete the steps to record the course to your CPE record. You will still need to provide a reason that a course was taken from a nonregistered sponsor, but you will do this at the time the course is recorded. Texas CPAs should keep in mind that they may not claim more than 50 percent of the total CPE credits from nonregistered sponsors in any three-year reporting period.

I’m going back to work after claiming retired status:

Many Texas CPAs that have previously claimed the retired status during their license renewal find themselves with opportunities to re-enter the workforce. You’ll want to take a look at Board [Rule 515.8](#) to make sure the work you are considering will require that your license return to an active status. If you are working in some association with accounting, which is broadly interpreted in the rules to include most work of a financial nature, you’ll need to remove yourself from retired status and return your license to an active status.

Usually these events don’t align with your annual renewal cycle, so you’ll need to contact the Board by email at licensing@tsbpa.texas.gov to request a new license renewal notice. Depending on the timing of the request, you will be asked to pay the license fee established by the Board for the period since you became employed. You must also meet the CPE requirements for the period leading up to re-entering the workforce. Most often this will require a retired Texas CPA to complete 40 credits of CPE, inclusive of the 4 credit Board-approved Texas Ethics course. Your CPE can always be updated online through the Online Services menu for individual licensees. If you happen to re-enter the workforce on or near your normal renewal month, you can easily opt out of the retired status at that time and complete the renewal steps.

How much CPE do I need after I first get my license?


When you receive your initial Texas license, you can verify your upcoming CPE requirement that is due by logging into your Online Services, Individual Licensee Login and selecting “Review your CPE Requirement” under the Continuing Professional Education menu (see screen shot on the next page). First time CPAs should see the following result: “Report 0.00 more CPE credits, of which 0.00 must be Board approved ethics credits.” Although this might seem odd, you do not have a CPE requirement in these first months of licensure and any CPE that you take during these first months will not count toward a future license period (see screen shot on the next page).

The first day of the month following your first full-year license renewal period (for example, if you were born on December 12, you should look on January 1) you will see your CPE requirement

“Report 20.00 more CPE credits, of which 0.00 must be Board approved ethics credits.” In the subsequent 12-month period, you do not have an ethics requirement but you will need 20 CPE credits to meet your next CPE requirement. As you record CPE courses via Online Services throughout the year, your reminder of how many credits you have remaining to complete will automatically update so that you can easily access this information.

Each year, your next CPE requirement will show exactly how many credits you will need in order to renew your license. After you have been licensed for four years and then for each subsequent year, you will need to have completed 120 credits of CPE in the preceding three-year period with a 20 credit minimum in any single year and a 4 credit Board-approved Texas Ethics course every other year.



ENFORCEMENT ACTIONS

Ratified at the September 20, 2018 Board Meeting

A. AGREED CONSENT ORDERS BEHAVIORAL ENFORCEMENT COMMITTEE

Respondent entered into an Agreed Consent Order (ACO) with the Board whereby Respondent involuntarily surrendered his certificate in lieu of further disciplinary proceedings.

The Board's discipline resulted from the Respondent having relinquished his certificate in Arizona in lieu of formal disciplinary proceedings arising from allegations of preparing and filing false tax returns, planning to defraud the IRS and diverting funds from an employer.

Respondents entered into an ACO with the Board whereby Respondents were suspended for two years. Upon the end of the suspension period, Respondents' certificate and license will be revoked; however, the revocation will be stayed, and Respondents will be on probation for eight years under certain conditions. Respondent received deferred adjudication and a 10-year probation for the felony offense of manufacturing or delivering a controlled substance.

Respondent entered into an ACO with the Board whereby Respondent was reprimanded, ordered to pay an administrative penalty of \$22,500 and administrative costs of \$171.20 within 30 days of the date of the Board Order.

Respondent was censured by the Public Company Accounting Oversight Board (PCAOB) for failing to comply with PCAOB Auditing Standard No. 7, Engagement Quality Review. Two partners of Respondent firm served as engagement quality reviewers on two audits immediately after serving as the engagement partner on audits, without satisfying the mandatory two year "cooling-off" period for former engagement partners.

Respondents entered into an ACO with the Board whereby Respondents were reprimanded, ordered to pay administrative costs of \$13,644.33, and Respondents' certificate and firm license were placed on limited scope status until a petition for removal is approved. Respondents are prohibited from performing audits, reviews and compilations, and other

engagements required by the Board to be performed in accordance with Government Auditing Standards issued by the Comptroller General of the United States, or OMB Circular A-133, *Audits of States, Local Governments and Non-Profit Organizations*, without a pre-issuance review by a pre-issuance reviewer approved by the Chair of the Technical Standards Review Committee.

Respondent Firm issued an audit report for a school district in which the Texas Education Agency determined that Respondent and Respondent Firm failed to test the work of the CPA firm retained by the school district to assist it in preparing for the audit and that the Respondent and Respondent Firm did not perform any entity level transaction tests as required by auditing standards.

Respondent worked as the Chief Financial Officer at Stanford Group Company ("SGC") where he participated in the preparation of financial statements for SGC, an affiliate of Stanford International Bank. In 2009, SGC and related entities were placed into receivership at the request of the United States Securities and Exchange Commission (SEC). Respondent signed financial statements that were submitted to the SEC that were false and misleading.

Respondent entered into an ACO with the Board whereby Respondent agreed to cease from engaging in the practice of public accountancy including, but not limited to, the use of the terms "CPA," "accountant," "auditor," "accounting services," and "auditing services." This also includes the performance or offer to perform attest services.

Respondent used the term CPA on her resumes and referred employment recruiters to the Board's website with the intent to cause the recruiters to believe she is the individual holding a license issued by this agency. Respondent has never held a license issued by this agency.

Respondents entered into an ACO with the Board whereby Respondents agreed to cease from engaging in the practice of public

accountancy including, but not limited to, the use of the terms "accountant," "accounting," "audit," and "accounting services."

Although Respondents have never held a license issued by this agency, Respondents were using terms restricted by the Act on web-based profiles, marketing websites and storefront signage as well as, asserting an expertise in accounting and auditing.

B. PROPOSALS FOR DECISION

The Administrative Law Judge (ALJ) concluded that Mr. Thakkar violated Board *Rules* 501.60, 501.70, 501.74, 501.83, 501.90(7), 501.93 and 527.4 and his individual license and firm certificate be revoked and he be assessed a \$60,000 administrative penalty and direct administrative costs of \$3,785.67.

Respondent was the founding partner and sole shareholder of Thakkar CPA, PLLC d/b/a The Hall Group CPAs. The ALJ found that between January 6, 2014 and January 29, 2015, Thakkar CPA issued 15 audit reports for public companies that 14 of the public companies ("issuers") included in filings with the SEC. Additionally, Thakkar CPA conducted 30 reviews of interim financial information included in Forms 10-Q that 11 issuers filed with the SEC.

The SEC alleged that Respondents knew, or were at least reckless in not knowing, that Thakkar CPA was not licensed in Texas to practice public

accountancy as The Hall Group CPAs and was not registered with the PCAOB.

The Board adopted an order approving the Proposal For Decision issued by the ALJ.

Rule Violations: 501.60, 501.74(b), and 501.74(d)

The ALJ found that Mr. Botley violated Board *Rules* 501.60 and 501.74 and recommended a two-year probated suspension, a \$25,000 administrative penalty, and \$66,890.68 in administrative costs.

Respondents performed the audits of the Beaumont Independent School District (BISD) for the Fiscal Years Ending 2010, 2011, and 2012, during which time, the Director of BISD and the district's Comptroller embezzled at least \$4,000,000.

The ALJ found that Respondents: (1) failed to perform and issue the BISD audits of BISD's financial statements in compliance with AU sections 314 and 316 by failing to adequately document and test internal controls of journal entries and wire transfers for the 2010, 2011, and 2012 BISD audits; (2) failed to exercise due professional care in the testing of internal controls over journal entries and wire transfers; and (3) failed to maintain appropriate documentation of their testing on internal controls to afford a reasonable basis for their conclusions.

The Board adopted an order approving the Proposal For Decision issued by the ALJ.

Continuing Professional Education Actions

The respondents listed below were not in compliance with the Board's continuing professional education (CPE) requirements as of the date of the Board meeting. Each respondent was suspended for the earlier of a period of three years, or until the respondent complies with the licensing requirements of the Act. Additionally, a \$100 penalty was imposed for each year the respondent continues to be in non-compliance with the Board's CPE requirements. The respondents were found to be in violation of Board Rule 523.111 (*Required CPE Reporting*) and 501.94 (*Mandatory Continuing Professional Education*), as well as Section 901.411 (CPE) of the Act.

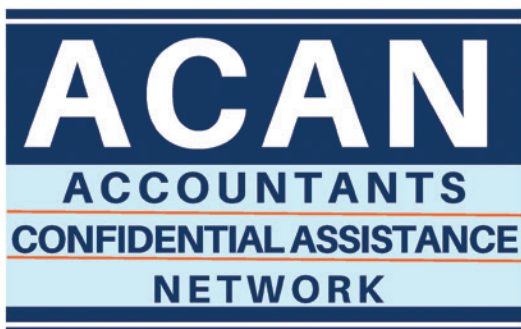
