### In Remembrance of Ronnie Rudd

**R**onnie Rudd, CPA passed away on September 14, 2020 at the age of 78 years old. Rudd was a distinguished alumnus of Baylor University. He joined Arthur Andersen in 1964 and became a CPA in 1966. He was made partner in 1975 and managed offices in San Antonio and Austin before his retirement in 2000. During 1983 through 1994 he was audit practice director for the Southwestern United States.



Mr. Rudd's service on the Board began in 1989. "I first met Ronnie when I interviewed for the position of executive director and he was on the interview panel," said Texas State Board of Public Accountancy Executive Director Bill Treacy. "He encouraged his colleagues to hire me, for which I'll always be grateful."

Rudd served as vice-chairman of the Board in 1991 and was the presiding officer of the Board from 1992 until 1995. He was the first presiding officer to be designated by a governor. Governor Ann

Richards designated him as presiding officer in accordance with a new provision in the *Public Accountancy Act* (the *Act*). Previously, the presiding officer was elected by the Board membership.

During his tenure, the *Act* went under legislative Sunset Review, and Rudd led the efforts to modernize the *Act* in many ways that continue to this day. Mr. Rudd served as a member of the American Institute of Certified Public Accountants Council for six terms and was the National Association of State Boards of Accountancy (NASBA) chair from 1995 until 1996. While at NASBA, he was instrumental in developing the Uniform Accountancy Act to streamline regulation among the states. He pioneered the idea of a computer-based CPA Exam and other initiatives, such as international and interstate reciprocity, and the 150-hour educational requirement.

Rudd received numerous honors from all levels of the profession, including the highest award bestowed by NASBA, the William H. Van Rensselaer Public Award for Meritorious Service. "Mr. Rudd hasn't served on the Board since 1995, but his influence on the Board has been monumental and still persists today," Treacy said. "I feel honored to have had the opportunity to work with him." ■

## In Memory of Dr. Ed Summers



**E**dward Lee Summers, Ph.D., CPA passed away at the age of 83 on September 13, 2020. Dr. Summers received a B.A. and B.S. from Rice University in Chemical Engineering and his M.B.A. and Ph.D. from the University of Texas at Austin. Dr. Summers was a Professor of Accounting, Emeritus member of the University of Texas at Austin and also a professor at Rice University where he taught accounting and other subjects. At UT Austin he served as Accounting Department chair for five years, and two years as chair of the Accounting Graduate Studies Committee before retiring in 2004.

Dr. Summers served as 1995-1996 President of the Texas Society of CPAs. Governor Bush appointed him to the Texas State Board of Public Accountancy (TSBPA) where he served from 1997 until 2005. He maintained his Texas CPA license for more than 55 years and was honored as a 50-year licensee at the December 2015 TSBPA recognition ceremony. During the ceremony he gave a keynote address in which he said "I am very glad I chose to be a CPA. No, I did not choose CPA status at age five. But later in life, I had real opportunities to be other things: an engineer, a Fortran programmer, a writer, an economist. I chose accounting. As a CPA, I chose teaching — first at Rice University, then at UT Austin," Summers said. "How did being a CPA help a faculty member?

I had access to the best minds and ideas in an active, growing, ethical, and responsible profession! The CPA profession! I benefited immeasurably from unique access to the likes of Robert Trueblood, Herb Miller, Bill Cooper, Harry Hopson, and many more. With help like that, teaching career advancement came easily. At every part of my career, the CPA profession was there for me," Summers said.

"The passing of Dr. Summers is a great loss to the accounting academic community and also to the profession," said TSBPA Executive Director Bill Treacy. ■

## Fingerprint-Based Background Check Updates


The Board began phasing in fingerprint-based background checks for all Texas CPAs on October 15, 2019. This measure was in response to the enactment of House Bill 1520, which standardized the Board's fingerprinting process. In the ensuing 12 months, almost 34,000 licensees and non-CPA firm owners have successfully completed this new requirement. However, the onset of the COVID-19 pandemic has caused no small amount of disruption for many in completing this requirement. Heightened safety guidelines and precautionary safeguards prevented many from venturing out in public spaces. In addition, IndentoGo, the sole source vendor contracted by the Texas Department of Public Safety to carry out the fingerprinting process, saw permanent closure of some facilities and reduced availability of appointments at many others. While Texas licensees have made good progress, there still remain more than 20,000 CPAs to be fingerprinted. The chart below shows the number of Texas CPAs by renewal month that still need to be fingerprinted. The Board is compelled by law to complete this requirement for all Texas CPAs by August 31, 2021. The clock is ticking!

As a reminder, the new requirement applies to all licensees and non-CPA firm owners. There is no exception for Texas CPAs living outside the state or currently claiming an exemption from the CPE requirements. Licensees who hold the retired or disability status with the Board do not need to get fingerprinted, unless they seek reinstatement. Licensees who were fingerprinted electronically for the Texas CPA license after **September 1, 2014** may not need to get fingerprinted again.

If you log in to Online Services at [www.tsbpa.texas.gov](http://www.tsbpa.texas.gov) and the banner on your individual account reads "Your legislatively mandated CPA License Fingerprint Status is: **Need to be fingerprinted**," you still need to complete the process. To schedule your appointment, simply visit <https://uenroll.identogo.com/workflows/11J9GV> and follow the instructions.

Board staff can help answer your logistical fingerprinting questions; however, they cannot change the law. ## New Congressman Conaway Archive, Exhibit, and Endowment

**A**new U.S. Congressman Mike Conaway archive and exhibit will be featured in the soon to be completed Angelo State University (ASU) Mayer Museum. The exhibit will showcase Conaway's career, primarily as U.S. Representative for the 11th District of Texas from 2005 through 2021. ASU reports that the exhibit will feature interactive touchscreens, documents, memorabilia, and themed displays focusing on Conaway's committee work, chairmanships, early life, and guiding principles.

Congressman Conaway represents 29 counties in the 11th Congressional District of Texas. He has served in the U.S. House of Representatives since 2005 and will be stepping down following his current eighth term in office. Conaway and his wife, Suzanne, live in Midland and have four children and seven grandchildren. He grew up in Odessa and has a background as a certified public accountant. He was appointed as a member of the Texas State Board of Public Accountancy (TSBPA) by Governor George W. Bush in 1995 and served as presiding officer of the Board from 1997 until 2003. He was also a member of the TSBPA and Texas Society of CPAs task force on the Uniform Accountancy Act. In September 2000, he testified on behalf of the TSBPA at the Securities and Exchange Commission's (SEC) hearing regarding the proposed changes to the SEC's Independence Rules. Conaway also served as chairman of the National Association of State Boards of Accountancy (NASBA) after serving two terms as the NASBA Southwest regional director.

In 2019, Conaway was named an Honorary Alumnus by ASU. He recently gifted \$250,000 to establish the K. Michael Conaway Fellowship Endowment, which will be used for construction and furnishing of the exhibit. The endowment will also fund a fellowship program in Washington, D.C. that will include the K. Michael Conaway Fellowship in Agriculture and the K. Michael Conaway Fellowship in National Security. The fellowships will be open to ASU graduate students based on merit, and will place them in organizations of importance and influence in Washington, D.C., with the endowment also covering their housing and per diem expenses. The Conaway Fellowship Endowment may also be used for the ongoing operation of the Conaway Exhibit and to obtain speakers at various ASU Mayer Museum events that highlight the Conaway Exhibit. The order allowed the Respondents to petition for reinstatement before the SEC after a period of two (2) years from the date of the SEC Order, under certain conditions.


