### Ernst & Young LLP Assessed Reprimand and \$3M Penalty by Texas Board

he Texas State Board of Public Accountancy (TSBPA) approved an Agreed Consent Order assessing a reprimand and a \$3,000,000 administrative penalty against Ernst & Young LLP (EY) on November 9, 2023. The penalty was the largest administrative penalty that the Texas Board has ever assessed against a CPA firm.

EY was the subject of a Securities and Exchange Commission (SEC) order that included a number of professionals licensed as Texas CPAs who were found to have cheated on ethics exams and on a variety of other examinations required to maintain their Texas CPA licenses. The SEC had further determined that EY had withheld this misconduct from the SEC staff who were involved in the investigation.

"The action represents the Board's message to all Texas licensees that the Board will not tolerate any form of professional misconduct," said TSBPA Executive Director William Treacy. **More info**

### Senate Bill 510 Helps Protect the Privacy of Texas CPAs

Lawmakers and Governor Greg Abbott approved Senate Bill (SB) 510 during the regular session of the 88th Texas Legislative Session. SB 510 requires state agencies, including the Board, to maintain the confidentiality of licensing information. Information in a license application, such as email addresses, home addresses, and date of birth have been added to the list of information the agency is required by law to maintain as confidential.

However, please note that SB 510 only applies to individual licenses and does not apply to firm licenses. Therefore, if you are practicing out of your home and you don't want your home address to be available to the public, you may want to consider creating a P.O. Box for your firm. You may use **Online Services** on the Board's website to update your contact information.

### Increasing the CPA Pipeline

The Texas State Board of Public Accountancy (TSBPA) has many efforts underway to foster the growth of the profession and fuel the CPA pipeline. The public interest is best served when CPA services are readily available. Here are a few examples of the Board's recent efforts to address the dwindling numbers of students who pursue the CPA designation:

### Requirements to Take the Exam Before and After September 1, 2023

Effective September 1, 2023, the Texas *Public Accountancy Act* has been amended. It permits candidates with a baccalaureate or higher degree recognized by the Board and 120 semester hours of Board recognized courses, including no fewer than 24 semester hours of accounting, of which 21 must be upper level accounting, to take the CPA Exam. Please note that candidates are still required to have 150 semester hours of Board-recognized courses, six additional semester credit hours of upper-level accounting, and completion of a three-semester hour, Board-approved ethics course in order to become a certified public accountant.

### Applicant Reassessment Program

The TSBPA launched an Applicant Reassessment Program (ARP) to assist individuals who were taking the CPA Exam and through a hardship occurrence, lost CPA Exam credits and may wish to pursue the CPA designation again. An applicant who earned and lost credit for one or more CPA Exam sections between January 1, 2020 and January 1, 2024, may be eligible to apply for the ARP. An unforeseeable and uncontrollable hardship event may include, but are not limited to, accidents and natural disasters affecting the health of an applicant or member of the applicant's immediate family. Candidates interested in the ARP should:

- Review the Applicant Reassessment Program Info Sheet
- Complete and submit the Applicant Reassessment Program Form (X0034) with requested supporting documentation

### Scholarship Program Expanded

The TSBPA is pleased to announce that HB 2217 was approved by the Texas Legislature. The Texas State Board proposed this legislation, which expands the scholarship for fifth-year accounting students to **all** Texas accounting students who have **completed 15 semester hours of upper-level accounting coursework**. ### Experience, Learn and Earn Program

The Experience, Learn and Earn (ELE) Program was developed by the American Institute of Certified Public Accountants and the National Association of State Boards of Public Accountancy. ELE is an integrated education and experience program for students who need a path to the 150 credit hours required for CPA licensure. It allows students to earn up to 30 educational credit hours while they are employed with a CPA firm and earning a living. Respondent entered into an ACO with the Board whereby Respondent was reprimanded. Respondent would also be placed on limited scope if and when he comes out of retirement requiring him to have a pre-issuance review of any attest services.

Respondent issued audited financial statements for a commercial oil and gas company that failed to meet generally accepted auditing standards and generally accepted accounting principles.

### **Continuing Professional Education Actions**

The respondents listed below were not in compliance with the Board's continuing professional education (CPE) requirements as of the date of the Board meeting. Each respondent was suspended for the earlier of a period of three years, or until the respondent complies with the licensing requirements of the Act. Additionally, a \$100 penalty was imposed for each year the respondent continues to be in non-compliance with the Board's CPE requirements. The respondents were found to be in violation of Board Rule 523.111 (Required CPE Reporting) and 501.94 (Mandatory Continuing Professional Education), as well as Section 901.411 (CPE) of the Act.
