appreciates Mr. Treacy's excellent leadership and dedication to the Board over these past 35 years.

Mr. Treacy currently serves on the U.S. International Qualifications Appraisal Board, which he chaired for seven years, and was also a member of the National Association of State Boards of Accountancy (NASBA) Committee on International Delivery of the CPA Exam and the NASBA Global Strategies Committee. He previously served on the NASBA National Steering Committee; the American Institute of Certified Public Accountants (AICPA)/NASBA Uniform CPA

Examination Task Force; the Computerization Implementation Committee; the Alternative Practice Structures Task Force; the Uniform Accountancy Act Education and Imple-

mentation Committee; the International Reciprocity Committee; the State Board Administrators' Committee (including two years as chairman); the Acceleration of Changes in the CPA Exam; the Future Licensing, Litigation,

Legislation Task Force; the Ethics Committee; and the Operation LEAD Task Force.

Mr. Treacy is an honorary member of the Texas Society of Certified Public Accountants and the recipient of the 2009 Lorraine P. Sachs Standard of Excellence Award. Handling Client Files After CPA Practice Transitions

The Texas State Board of Public Accountancy (TSBPA) recently adopted Board **Rule 501.79** regarding the responsibilities of a licensee and a licensee's firm concerning the transfer or return of client files after the sale, transfer, discontinuation, or acquisition of a CPA practice. In adopting the new rule, the TSBPA also emphasized the responsibilities of the licensee or licensee firm that is acquiring the practice.

A licensee or licensee's firm that sells or transfers all or part of the licensee's practice to another person, firm, or entity and will no longer be employed by or retain any ownership in the practice is required to:

(1) submit a written request to each client subject to the sale or transfer, requesting the client's consent to transfer its files to the successor firm. The licensee should not transfer any client files to the successor firm until the client's consent is obtained. The licensee is required to retain evidence of consent for at least five years from the date of sale or transfer of the firm;

(2) arrange to return any client records, not transferred to the new firm, unless the licensee and client agree to some other arrangement; and

(3) retain in a confidential manner, client files where the licensee is unable to contact the client, for at least five years from the sale or transfer. When practicing before the IRS or other taxing authorities or regulatory bodies, licensees should ensure compliance with the most restrictive retention requirements.

A licensee who discontinues his or her practice but does not sell or transfer the practice to a successor firm, is required within 30 days of the discontinuation of the practice to:

(1) Notify each client in writing of the discontinuation of the practice. The licensee must retain evidence of notification made to clients for at least five years. The licensee is not required to provide notification to former clients of the firm.

(2) Return any client records that the licensee is required to provide to the client, unless the licensee and client agree to some other arrangement.

(3) Retain in a confidential manner, client files where the licensee is unable to contact the client, for at least five years from the discontinuation of the practice. When practicing before the IRS or other taxing authorities or regulatory bodies, licensees should ensure compliance with any retention requirements that are more restrictive.

(d) A licensee who acquires all or part of a practice from another person, firm, or entity (predecessor firm) should be satisfied that all clients of the predecessor firm subject to the acquisition have consented to the licensee's continuation of professional services and retention of any client files or records the successor firm retains.

TSBPA Enforcement staff are available to answer any questions that you may have about this rule.

AGREED CONSENT ORDERS BEHAVIORAL ENFORCEMENT COMMITTEE

Respondents entered into an agreed consent order (ACO) with the Board whereby Respondents were reprimanded and required to complete four hours of continuing professional education in the area of practice management and four hours of ethics. In addition, Respondents must pay a \$500 administrative penalty and \$851.20 in administrative costs within 30 days of the date of the Board Order.

Respondents encouraged a client to apply for the Employee Retention Tax Credit without sufficient skepticism, and incorrectly advised the client there was “no risk” of repayment.

In addition, Respondents must pay a \$500 administrative penalty and \$851.20 in administrative costs within 30 days of the date of the Board Order.

Respondents took on tax preparation engagements while unable to adequately perform the services resulting in insufficient guidance to a client.

Respondent pleaded guilty to Introduction of an Adulterated Drug to Interstate Commerce, a class E felony, and was sentenced to one year of probation. She is prohibited from possessing, transferring, or distributing medication intended for the medical treatment of animals without prior permission from the probation officer. Respondent may not provide any form of veterinary diagnosis, treatment, or advice without permission of the probation officer and cannot work in any employment without approval of the probation officer.

Respondent, as the owner and resident manager of a licensed firm, failed to respond within 30 days to a Board communication requesting a response.

Respondents entered into an ACO with the Board whereby Respondents were reprimanded and assessed an administrative penalty of \$25,000 and administrative costs of \$1,005.90 to be paid in monthly installments beginning 60 days from the date of the Board Order. Further, Respondents were placed on limited scope prohibiting them from performing audits and reviews, but permitting performing compilations in accordance with the conditions delineated in the ACO.

Respondents were censured, assessed a \$65,000 civil money penalty, and barred from practicing before the Public Company Accounting Oversight Board (PCAOB) for violating multiple PCAOB rules and standards in connection with an audit report for an issuer regulated by the PCAOB. Respondents failed to: obtain sufficient appropriate audit evidence for revenue and inventory; perform sufficient procedures to test journal entries in response to the risk of fraud; communicate all required matters to the issuer’s audit committee; determine all critical audit matters; and identify significant findings and issues in an engagement completion document.

CPE Actions

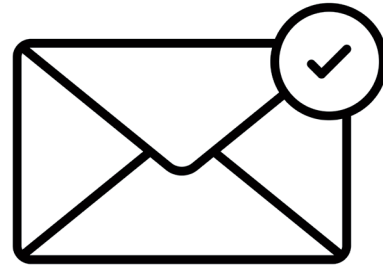
