Gov. Abbott Names Cavazos Presiding Officer, Appoints Four New Board Members

overnor Greg Abbott designated Manuel "Manny" Cavazos IV, Esq., CPA as the presiding officer of the Texas State Board of Public Accountancy (TSBPA) and appointed four new Board members on September 29, 2017. Mr. Cavazos of Austin has replaced J. Coalter Baker, CPA whose term expired. Newly-appointed Board members include Lisa A. Friel, CPA of San Antonio; Jamie D. Grant of Arlington; James D. "Jim" Ingram IV, CPA of College Station; and Debra Saldaña Sharp of Houston. The new Board members will each serve a six-year term and have replaced members with expired terms.



Manuel "Manny" Cavazos IV, Esq., CPA

Manuel Cavazos IV was appointed presiding officer of the Texas State Board of Public Accountancy following completion of a term as chair of the Texas Credit Union Department. Cavazos is a self-employed CPA and attorney, previously of Brownsville and Laredo.

Cavazos has extensive experience in natural gas, having served as an executive vice president for Western Gas Interstate and as an officer for

the NYSE company. He was head of cost accounting for the oil production facilities in the Alaska North Slope for Halliburton/Brown & Root. His international experience includes serving as the controller for the support facilities for the Airborne Warning and Control System and F-16 for five bases in Saudi Arabia for CRS, Inc. and Metcalf & Eddy with extensive travel throughout Europe. Additionally, he was employed as the head of legal and financial compliance for water districts for the state of Texas.

Cavazos is a member of the Texas Society of CPAs, the American Bar Association, and the California State Bar. He is a former board member of the Greater Austin Hispanic Chamber of Commerce, and a former board member and treasurer of the Texas Society to Prevent Blindness. Cavazos received a Bachelor of Arts in Economics from the University of Texas at Austin and a Juris Doctor from Taft Law School.

Extensions for Licensees and Candidates Affected by Hurricane Harvey

The Board extended due dates through the end of October 2017 for CPAs with license renewals due in August or September 30, 2017 who were having difficulties completing CPE or renewing their license online.

The Board also extended CPA Exam eligibility dates through October 31, 2017 for candidates who were scheduled to take a section of the Exam and couldn't test due to Prometric test center closures, or displacement caused by the hurricane. NASBA and Prometric worked with the Board to resolve candidate issues as quickly as possible.

The Board will consider additional extensions on a case-by-case basis for those still recovering from Hurricane Harvey.

J. Coalter Baker, CPA

J. Coalter Baker, CPA of Austin was appointed as presiding officer of the Texas State Board of Public Accountancy by Governor Greg Abbott in 2015. He was first appointed to the Board in 2003 serving in various leadership roles, including presiding officer until 2008. He was appointed to a full term in 2011 to serve through 2017.

In addition to presiding officer, Baker served as assistant presiding officer, chair of the Executive Committee, and has chaired every major Board committee and task force. He served as the National Association of State Boards of Accountancy (NASBA) southwest regional director for three years and was recently elected to the position of NASBA director-at-large. Baker is chair of the Uniform Accountancy Act Committee and serves on the American Institute of Certified Public Accountants' (AICPA) Professional Ethics Executive Committee.

Over the years, Mr. Baker's NASBA participation has also included work on the

organization's Strategic Plan, Ethics, and Nominating committees, and the Substantial Equivalency Task Force and Ethics Directory Subcommittee, which he chaired. Mr. Baker has also been a member of the AICPA's Tax Practice Responsibilities Committee, as well as the Personal Financial Planning and Taxation divisions. Help Us Identify Unlicensed Individuals and Firms Offering Accounting Services

Over the last three years, the Board's Unauthorized Practice of Public Accountancy Program has identified more than **1,700** unlicensed individuals and firms claiming to be CPAs or offering accounting or attest services to the public. Although this program has been very successful, we know that there continues to be false or misleading advertising. There are approximately 70,000 licensed CPAs in Texas who can help protect the public from individuals and firms misrepresenting their qualifications.
